Based on papers presented at a workshop held at Sciences-Po in Paris, it addresses past and future challenges related to global governance. Each of the contributions picks up on the more general theme of the values that do or should inform global administrative law. In this way, the book provides a novel and thought-provoking commentary on this most engaging area of debate. Values in Global Administrative Law will be of interest not just for public lawyers, but also for social and political scientists working on globalization and/or international relations. It will also be an invaluable resource for undergraduate and postgraduate courses that touch partly or exclusively on the challenges of global governance.
